Desert Princess Palm Springs Country Club Membership Agreement

Please initial all lines in the agreement. If you have any questions, please refer to the FAQ.

Applicant eligibility and membership rights are as delineated in, and each Club Member agrees to abide by, the Association's and Club's Restated Declaration, and the Club Rules and Regulations ("Governing Documents").

The annual season lasts from Oct. 1 to Sep. 30. Dues for annual memberships are payable in a single payment upon submission of a signed Application. The Association may, although it is not obligated to, provide payment options in equal installments as prescribed by the Board. The Club may assign any and all of its rights and obligations pursuant to this Membership Agreement and the Governing Documents to the Association without prior notice to the Non-Homeowner Club Members. Should this occur, all Club Members will receive written notice of such assignment once it is complete. Member acknowledges that membership fees are not prorated, and applying after October will result in back-charging as necessary.

I, the applicant, understand that these payment options are not pro-rated, and that I will be paying the year's payment in full before the season's end. _____

Failure to pay dues, fees, or charges will result in suspension of all related privileges until accounts have been paid in full. Any Member's account thirty (30) days past due is regarded as delinquent and is subject to late charges. The Club may suspend or terminate membership rights upon notice, and may call the Member to a hearing before the Board of Directors for delinquency or violation of the Governing Documents. Suspensions shall remain in effect until the balance owed is paid, or for violations, for a period of time to be determined by the Board. Suspension, termination, or non-use of the facilities shall not discharge or offset the obligation to pay dues, fees, or charges. In addition to suspension or termination of membership for violations of the Governing Documents, the cost of any and all damages will be charged to the Club Member.

The Club reserves the right to refuse or not renew any membership. All applications are subject to review by the Board or its designated representatives. This membership is valid only for the person(s) designated on this application. Any charges incurred by authorized account signatories or by guests of the designated Club Members are the responsibility of the Member. The Member authorizes the Club to charge the Member's credit card for any and all charges incurred by the Member, the Member's authorized account signatories, or by the Member's guests when said charges are more than sixty (60) days past due, including any late fees and interest. It is the responsibility of the Member to notify the Club's accounting office in writing, in a timely manner, of any changes of authorized signatories and when the credit card noted above is no longer valid. Club Members are required to keep a valid credit card on file with the Club at all times; if an application is received for a Member who does not have a card or other payment information on file, or if the information is out of date, the application may be rejected. Any and all additional persons designated on this membership application are responsible for abiding by all terms and conditions of this Agreement.

I, the applicant, understand that I am responsible for ensuring my payment information is up to date and my account is paid each month, and that my signature authorizes the Club to charge my card on file should my account become delinquent. _____

Violating the Governing Documents will result in: A written warning notice, except for Code of Conduct violations, for the First Infraction. For Code of Conduct and/or the Second Infraction, a written notice and disciplinary hearing before the Board of Directors or the Board Hearing Panel, which may include a fine and membership suspension. The Member is responsible for any attorney’s fees and costs incurred by the Club in connection with the collection of dues, fees and charges. In the event a dispute arises over the interpretation or enforcement of the Agreement, the prevailing party shall be entitled to attorney’s fees.

I, the applicant, understand that I am responsible for my conduct and am aware of the consequences should I violate the rules laid down in the Governing Documents. _____

“Family” as it applies to the Family plans is defined here as no more than two golfing adults living in the same household, and children must be dependents living at home under the age of 22. “Individual” as it applies to the Individual plans is defined here as a single adult; there may be no sharing of this membership between two adults. “Twilight” as it applies to the Twilight plans is defined here as play beginning after 2PM Oct.-May and after 8AM May-Sep. Sharing a membership may result in a hearing and loss of privileges.

I, the applicant, understand the definitions of the plans as laid out above, as well as the consequences of violation. _____

For every player that no-shows or cancels within 24 hours of the scheduled time, the Member responsible will be charged the appropriate green fee rate. This includes when, for example, a foursome is booked and only two players arrive.

I, the applicant, understand the terms of this fee. _____

The Member is required to receive and keep on their golf bag the Member tag for the relevant season. This tag will be supplied at no cost, as it will help staff identify the player as a Member. The Member agrees to follow the course rules, including keeping golf cars on paths when available around tees, greens, and on all par 3 holes. Golf cars must be kept a minimum of 15 yards away from the greens at all times. The Member understands that they are required to pair up when using club-owned golf cars even with the annual plan, and agree to pay the \$15 additional rental fee when using our fleet golf cars unless they have paid for an annual golf car plan. Violating these rules may result in a hearing, which could include a fine and/or restriction of privileges.
